#### 4.1. DESCRIPTION OF FIRST AID MEASURES

##### INHALATION

### 7.1. PRECAUTIONS FOR SAFE HANDLING

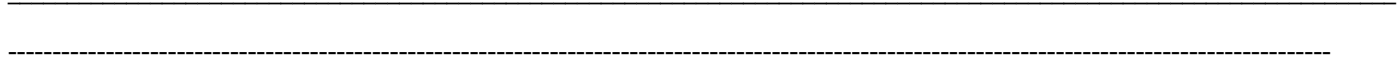
