Small spills: normal antistatic work clothes are usually adequate. Large spills: full body suit of chemical resistant, antistatic material is recommended.

## 6.2. ENVIRONMENTAL PRECAUTIONS

**Large Spills:** Dyke far ahead of liquid spill for later recovery and disposal. Prevent entry into waterways, sewers, basements or confined areas.

## 6.3. METHODS AND MATERIAL FOR CONTAINMENT AND CLEANING UP
